### AFFIDAVIT

I, **Manoj Kumar Patel**, Son of Kamaladhar Patel, age 40 years, Director of **Shree Chandagiram Educational Society**, running the **Modern Public School**, do hereby solemnly affirm and sincerely state as follows:

1. That **Shree Chandagiram Educational Society** is a registered Society under the **Society Act, 1973**.
2. That the **Shree Chandagiram Educational Society** is of **Non-Proprietary Character**.
3. That the School is being run as a **community service** and not as a business and that **commercialization does not take place** in the School in any manner whatsoever.
4. That no part of the income from the Institution is being, and shall be, diverted to any individual in the Trust/Society/Company/School Management Committee or to any other person/entity. The savings, if any, after meeting the recurring and non-recurring expenditure and contributions to developmental, depreciation, and contingency funds, shall be further utilized for promoting the School and extending the cause of education in the same School only.
5. That the School is **not paying any charges** towards using name, motto, logo, or any other non-academic activities to any other institution, organization, or body.
6. That the School shall **not open classes under BHARTIYA SHIKSHA BOARD pattern** for classes **IX/X/XI/XII** and shall not use the **BHARTIYA SHIKSHA BOARD** name in any manner without obtaining proper **Affiliation**.
7. That the **Principal and Correspondent/Manager** of the School have individually gone through the provisions contained in the **Affiliation Bye-laws and Examination Bye-laws**, and the circulars issued by the Board from time to time. The School undertakes to **abide by all the said provisions and legal directives**.
8. That the School shall ensure **compliance with all statutory requirements** like **EPF, ESI, and Labour Laws**, and all other applicable laws with respect to the School and its staff.
9. That the School shall ensure that **Building Safety, Fire Safety, Water Safety, Health, and Hygiene Certificates** are being issued or renewed by the concerned Municipal or State Authorities from time to time as per the prescribed norms.
10. That the School shall ensure that all **required infrastructure** is available before starting classes and shall continue throughout the session.
11. That the School shall ensure the presence of a **sufficient number of qualified Teachers** as per the provisions of the Affiliation Bye-laws before starting the classes.
12. That the School shall follow the **Fee provisions** contained in the Affiliation Bye-laws and shall **disclose fee details to the students/parents every year** before the session starts, without resorting to any **hidden charges**.
13. That the School shall **not compel any student or parent to buy books/stationery/uniform from any particular shop**.
14. That the School shall **strive to make efforts for environmental conservation**.
15. That the School shall ensure that it **fulfills all essential requirements before applying for Affiliation**, and shall **comply with all post-affiliation conditions and general rules** as laid down in the Affiliation Bye-laws or as notified by the Board from time to time.

16. That if the Affiliation has been granted with certain conditions, the School shall **not start BHARTIYA SHIKSHA BOARD pattern classes** without submitting a **certificate/affidavit** to the effect that the School has complied with all the conditions imposed by **BHARTIYA SHIKSHA BOARD** and the **post-Affiliation conditions** contained in the Affiliation Bye-laws, along with general rules.
